Dear Phil,

I will endeavour to provide you information where you can obtain the following:-

1. Evidence of mercury poisoning for Lynette Croll, Trevor Croll and Harry Croll.
2. Evidence of symptoms of poisoning
3. Evidence of motive
4. Evidence of opportunity

To ask a doctor if he can say whether Lynette Croll or Trevor Croll were poisoned with mercury requires from that Doctor more knowledge than is available to him. He must answer no. Ask the doctor, did you treat Lynette Croll and Trevor Croll for mercury – then he can answer this question. Mercury is an environmental poison and can be got from eating very old fish and old dental amalgams.

I have attached a paper on mercury and its symptoms.

How mercury works as a poison I now understand. Mercury behaves like zinc in the body in that it strongly latches onto where zinc would normally be and thus zinc is lost from the body. Mercury also interferes with magnesium. Both zinc and magnesium are involved with over 300 enzyme reactions. Enzymes support the bodies protein metabolism, thus the hair falls out, the blood homocystine and fibrinogen levels rise, blood gets more likely to clot, and all sorts of things go wrong.

1. Evidence of mercury poisoning for Lynette Croll, Trevor Croll and Harry Croll

The attached copy of the affidavit supplied to the Queensland court contains documents that will support you in this matter. It contains medical reports and my statements etc. This is to be mailed to you.

Evidence of poison from Dr Jaa, Suite 6, Riverwalk One, 140 Robina Town Centre, Robina Qld 4230, Phone 07 5562 2088. he treated Lynette Croll for mercury poisoning with a compound called DMG.

Dr Bradey, Your health Carina treated Trevor Croll and Lynette Croll for mercury poisoning. 830 Old Cleveland Rd, Carina Qld 4152. Phone 07 3395 2455.

Mercury will also cause puffy gums, Dr Peter Helen, Dentist, observed Lynette Croll with very puffy gums. 11 Dallas Parade, Keperra 4054. Phone 07 3855 5199.

My father and mother were treated by Dr Michael of East Care Medical Clinic, Main St Pakenham, who noted various symptoms for my mother and I presume my father. He noted that my mother's hair was falling out. He did three colonoscopies for my father when he had stomach cancer. The stomach cancer was obviously not related to the symptoms that Dr Michael was searching for the cause of. I submit that the mercury my sister was administering caused the symptoms Dr Michael was looking for.

My mother and I also saw Dr Dhillon, at Bunyip who was spoken to by my sister, and then tried to get my mother to send me away from her. Dr Dhillon diagnosed possible gall stones for me and filled out a script for an ultrasound. I now know that the pains were liver pains caused by mercury poisoning.

The Doctor that Dr. Dhillon purchased his practice from, Dr?? a woman, sent me for an endoscope because of stomach pains which I now know was caused by mercury.

Dr. Hanner of Your health in Camberwell, treated my mother for numbness and pins and needles in her hands and feet, he found she was zinc deficient and magnesium deficient. The treatment was a combination of vitamin and mineral supplements and EDTA Intravenously. Both my mother and I had about 14 EDTA chelation treatments which is also a treatment for heart arrhythmia, lead & mercury poisoning, arteriosclerosis – it cleans the white plaque out of the arteries and removed heavy metals from the body. We had this treatment not realising we were actually being poisoned and had been poisoned. We were there because of the symptoms.

Evidence of symptoms of poisoning

These doctors will have made notes of the symptoms Lynette Croll and to a lesser extent I was having. They have recorded heart arrhythmia and others. The symptoms of mercury poisoning indicates mercury poisoning. There is a pattern match.

DMPS Challenge works by attaching itself to mercury thus making mercury water soluble then the mercury can be urinated. The test indicates the amount of mercury in a person. Because my mother had poor kidney function Dr Brady did not administer the full amount, thus her results will significantly understate how much mercury she had in her.

This test was done after she had had 6 months of DMG treatment from Dr Jaa.

Evidence of motive

Two days after my father died John Gerlach told Bill Moore, the tenant at the farm at Longwarry, that he had to get out because the farm was on the market. Faye thought she was executor and as such had control, and she was beginning the process of selling up everything, and was going to take it all.

Faye was reported to Ray De Reus and Peter Bell for having stolen from my mother.

Faye had stolen my father's horse, Bunyip Bell and it was wrongly registered to Bruce James, her boy friend. The horse had been recovered and Faye was angered that she was not allowed to get away with this crime.

Faye has provided "evidence" to both VCAT Guardianship List and the Guardianship Tribunal in Queensland, where she states that I changed my father's will. EAN Newman, solicitor was there at the time and was witness to my father's signing his will.

My mother has told a story of how a beet root and carrot juice drink burnt my mother's throat and caused her grief that lasted several months.

Evidence of opportunity
Faye moved in and lived with my parents.

I will be bringing most of this out in my trial when I subpoena these doctors for their medical evidence. Plus other witnesses. So keep a watch at the trial.
