Dear Sir,

Further to my letter of the 25th August I wish to ADD:

I now enclose two additional reports of heavy metal poisoning. The reports sent to you todate show:-

Son: Trevor Croll with mercury poisoning
Grand son: Leonard Croll with mercury and arsenic poisoning
Mother: Lynette Croll with Lead, mercury and arsenic Poisoning.

Lynette Croll has had treatment from Dr Jaa in Robina Qld "DMG" now for six months 14 chelations and is still poisoned. She had 14 EDTA Chelations in Victoria, Your Health Camberwell, Dr. Hanner and Dr Jaa

I had 14 chelations also.

With so much poisoning going on in the family it must be assumed that my father has a high probability of having been murdered with heavy metals which caused his stomach cancer. Henry Theodore Croll is buried in the Bunyip Cemetry, Lynette Croll his surviving and poisoned wife lives at 59 Haywal Street, Taigum Qld Phone 07 3865 2696. She lives in Queensland because it was unsafe for her to live in Victoria.

Note the level of arsenic poisoning in Leonard Croll is high enough to cause severe complications. He went yellow and began to die, he had significant liver failure and very significant liver pains. He is lucky to have survived this poisoning episode.

The following is the contents of my letter of 25th August 2005.

My father Henry Theodore Croll dies on the 13th June 2003. I have strong reason to believe he had been deliberately poisoned with heavy metals, namely mercury.

Reasons are:

I have mercury poisoning. See attached report from Sullivan and Nicholaides. Research on the internet shows that the half life of mercury poisoning is 90 days. That is half the mercury is gone after 90 days. Our house in Bunyip had been entered several times even though we had made an effort to secure it by changing the locks. I verily believe my sister Lynette Faye Johnson was entering our house. In about September 2004 we reported this to the Police. The Yoghurt in the refrigerator caused my mother and myself stomach upset and diarrheal. I personally got an anus irritation that was persistent.

When I backtrack and consider my symptoms I verily believe this is when I received the last dose of mercury, just before my mother and I escaped to Queensland. My mother has been diagnosed with lead, arsenic and mercury poisoning.

My father had complained of an anus irritation and had stomach pains and internal bleeding for several years before his death. My sister had been living in the house with my mother and my father. I had observed before his death that he was considerably manic in his plans and behaviour. He organised fencing on the farm that was inappropriate, a building site that was inappropriate, and did other compulsive things. Having studied this situation and tried to determine where my mercury and my mother's mercury came from I firmly believe my sister deliberately administered it.

My mother thought she was allergic to beet root and strawberries. She isn't but does recall other times when she had severe reactions to these foods when served by my sister. In hindsight, they had been laced with poison. My sister made a point of giving my father a cup of tea when she came home from work. I believe this was done for the improper purpose of murdering my father. My sister would bring home some cakes for us to eat, I firmly believe these must have been laced with poison.

My sisters together, led by Faye, made an application to the Guardianship List to gain control of my mother – administrator and guardian. Faye constantly made the claim that my mother was demented. Dementure is a symptom of mercury poisoning. My mother suffered ill health, symptoms including:-

- Hair loss
- Chronic fatigue
- Hear arrhythmia, atrial fibrillation that caused two strokes in 2004.
- Numbness in her hands and feet and pins and needles
- Inflammation of her gums
- Panic attacks that left her totally incapacitated for several days
- Emotional feebleness, a tendency to have fits of distress and confusion
- She became very frail

All known to be caused by mercury poisoning.

That my sister was prepared to poison my mother and myself I can conclude that she was prepared to poison my father. My father suffered symptoms similar to those my mother and I suffered from the poison. Two days after my father died my sister tried to sell the family farm and she went through the family home and stole lots of valuable property, including my mother's coin and note collection that was probably worth \$2,000,000.00.

I ask that you order that my father's body be tested for heavy metal poisons, mercury, arsenic and lead. Even though the official cause of death was stomach cancer the actual

cause of death was prolonged administration of mercury poisoning causing stomach cancer.
